#### AT THE END OF THE DAY

### LOWER KS2 (YEARS 3 & 4), KS1 & FOUNDATION STAGE (YEARS 1 & 2 and RECEPTION)

Pupils will not be allowed to leave school with anyone other than their normal carer unless we have been notified that someone else will be collecting them.

#### UPPER KS2 (YEARS 5 & 6)

A number of our older pupils are able to walk home safely on their own (in Terms 1, 4, 5 and 6 only) if parents/carers have given written permission. Please ensure your child's class teacher and the school office know that your child has your permission. Please do however let us know if you make any alternative arrangements for your child.

I am sure that you will agree that safeguarding our children is of the highest importance. If clear information is not given to staff then children will not be released without a confirmation call being placed to the usual parent/carer.

## Attendance Matters

Our attendance is currently at **96%**. At the start of the new academic year we thought it would be useful to remind you of the following:

- Please try to make medical appointments outside of school time as they do cause disruption to learning. If your child has to be seen during the school day please ensure that they don't take the whole day off and we may ask you to provide medical evidence.
- ♦ Being late has a negative impact on your child's learning. We do have to record and report all late arrivals to the Local Authority. School starts promptly at 8.55 a.m. and gates are open from 8.40 a.m. Please ensure your child is here on time.
- Ensure you contact school by 9.00 a.m. on your child's first day of absence.
- Holidays taken during the school term are extremely disruptive for both pupils and teaching staff and they should be avoided. Whilst it is recognised that there are exceptional circumstances when leave during the term may be required, parents/carers are asked to carefully consider the effects upon their children's learning.
- Please refer to NHS guidance regarding COVID-19 if your child/ren have any of the following: A new, persistent cough. High temperature (above 38 degrees). Loss of taste and/or smell.
