Year 4 Residential Visit to PGL Centre at Caythorpe Court, Lincolnshire Monday 3<sup>rd</sup> – Wednesday 5<sup>th</sup> March 2025

We are now in the process of planning our Year 4 residential visit  $3^{rd} - 5^{th}$  March 2025 to the PGL Centre at Caythorpe Court. This is in the next academic year when your child will be in Year 4. We will be joined on this visit by our peers from Colsterworth C of E Primary School.

Whilst at Caythorpe Court, the children will be involved in activities such as abseiling, archery, climbing, quad bikes, fencing, and various other activities. They are kept very busy! All activities are run by qualified instructors with specialist equipment provided by the centre. We have attached a copy of the 2024 activity list as a guide although please note that these might be subject to change.

This visit may seem a long way in the future but it is necessary to make reservations now to secure the places. Your child may seem young at the moment to participate but from past experience Year 4 have thoroughly enjoyed this type of visit and found it a worthwhile experience to learn new skills and qualities about themselves and indeed many parents/carers and children have regretted not accepting the opportunity when offered.

The total cost of this visit, which is dependent on final numbers attending, **should not exceed £220**. It includes all accommodation, activities, instructors' fees, meals, insurance, specialist equipment and coach hire.

If you wish your child to take part in this visit an initial non-refundable £40 deposit should be paid by ParentMail +Pay by 9.00 a.m. on Monday 3<sup>rd</sup> June 2024.

Further payment deadlines are as follows:

Please ensure all payment deadlines are met.

Full payment for the visit must be made **by 30<sup>th</sup> November 2024** at which point, if full payment has not been received, your child will be unable to take part in the visit and any payments made may be forfeited.

As this is a curriculum enrichment activity financial support towards the cost of this visit may be available for parents/carers in receipt of:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you apply on or after 1 April 2018 your household income must be less than  $\pounds$ 7,400 a year (after tax and not including any benefits you get)
